Crusaders

- 1. An application for scholarship/financial aid must have complete information on both the student and parent/guardian.
- 2. Parent/Guardian of a recipient is required to participate in the tax credit student scholarship program.
- 3. No full scholarships: maximum 75% of tuition total for anyone who receives non-designated funds (some extreme hardship exceptions).
- 4. A scholarship CANNOT be applied to delinquent tuition.
- 5. Parent/Guardian is required to be involved in school service. (i.e. must participate in 5 approved service activities per school year within the academic school year that the scholarship was received)
- 6. Behavioral/Academic probation CAN result in loss of scholarship.
- 7. Parent/Guardian must submit verifiable proof of household income.
- 8. The Faith Baptist Christian Academy Scholarship Committee determines any exceptions on a case by case basis.
